KEY PROJECTS AT LOCKHART GARRATT

Priors Hall Development Site, Corby

Management and implementation of annual monitoring scheme for a range of habitats and species including woodland, grassland, wetland, great crested newt, breeding birds, bats, butterflies and moths, badgers and reptiles. Ongoing monitoring scheme and also clerk of works role with regard to develop activities.
